**ELIGIBILITY:** Dogs must be permanently registered with UKC, have a Temporary Listing (TL) number, or have a Limited Privilege (LP) listing number by the closing date and time in order to Pre-enter. Entries for ineligible dogs will be returned.

**PAYMENT:** Payments may be made by cash, check, or money orders payable in U.S. funds to **“MMBC”**. No entry will be accepted without payment. Post-dated or returned checks do not constitute valid entry fees. MMBC will add a collection fee to the amount of each returned check. Exhibitors who repeatedly submit invalid entry fees may be put on a CASH ONLY basis.

**GENERAL INFORMATION:** There will be a potluck both days. Overnight security is not provided, and no dog(s) may be left overnight. Exhibitors may at their own risk\* leave crates and belongings overnight.

**ROUTE TO THE SHOW:** Directions - from the south and east - Get to Hwy 394/12. Take Hwy 12 west to Howard Lake. About a mile west of Howard Lake, take a right on County Road 5 (heading North) to Cty Hwy 35 (there is a stop sign at this intersection). Turn left (west) on 35 until you reach the gravel road Newcomb - this is a blind intersection and easy to miss. It is the first gravel road after you pass the T intersection with County Road 4; Newcomb is 1 mile west of that intersection. If you get to the stop sign at Hwy 3, you missed it. Turn right (north) on Newcomb. In 1/2 mile, the road turns to the right and becomes 5th St NW. After the turn, we are the first driveway on the left. Long driveway, yellow house on the hill with a vineyard below it. Fire number 13172 is posted by mailbox. Note that a river runs through the area and many roads stop and start. People who do not follow these directions and turn off early because they see a road name they recognize end up lost, because the roads do not go through.

**REFUNDS:** No refund of entry fees will be made for entries cancelled after the closing date, except in the cases of bitches that come into season or injured dogs. In those cases, refunds may be obtained by providing a veterinarian's certificate to the Event Secretary before the start of the trials. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee or UKC. If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee will be made. If, in the opinion of the host club, the well-being of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.
